The filled in Tender (Bidding) Documents must reach in the office of Director (Sports & Coaching), Directorate General of Sports & Youth Affairs Punjab, National Hockey Stadium Lahore by **07th April, 2020 at 11:45 am** at the latest. Tenders / Bids (Technical Proposals) will be opened **on the same date at 12:15 pm** in Conference Room No. 1, National Hockey Stadium, Lahore, in the presence of the bidders who desire to attend. The detail description and scope of work of required procurement are given in the Tender (Bidding) Documents.

1. The procedure adopted will be "Single Stage Two Envelops" as prescribed under PPRA Rules.
2. The Bidders should provide all information / documents as required in the Tender (Bidding) Documents.
3. The Bidder shall demonstrate his proven capability to provide the required Goods / Services as described in the Tender (Bidding) Documents
4. Bids (Technical & Financial Proposals) should be sealed / signed as per terms and conditions given in the General Instructions to Bidders of Tender (Bidding) Documents.
5. The Bidders are required to submit Technical Proposals and Financial Proposals in separate envelopes clearly mentioning the respective proposals
6. The Financial Proposal / Bid should accompany Bid Security in the shape of CDR / Bank Draft / Pay Order / Bank Guarantee for an amount of 2% of the total value of "Estimate Price" referred above.
7. The bidder is required to submit the bank statement / audited accounts for the last two years to establish his financial soundness.
8. The Applicant Bidder shall provide National Income Tax Number, Sales Tax Registration, Undertaking on judicial paper that the Firm / Company has not been blacklisted or has no litigation / arbitration / inquiry with any Government, Semi-Government, autonomous Body established or controlled by Government and Undertaking on judicial paper for adherence to time line.
