

[CLUB NAME] CONSTITUTION

PREAMBLE:

We, the members of [Club Name], in order to promote and develop the sport / game of [Sport / Game Name], to encourage sportsmanship and fair play, and to foster a sense of community and camaraderie among our members, do hereby establish this constitution for the governance of our Club.

ARTICLE I: NAME AND AFFILIATION

- (i) The name of this organization shall be [Club Name], hereinafter referred to as the "**Club.**"
- (ii) The Club may seek affiliation with relevant PROVINCIAL national and international sports governing bodies, provided that such affiliation does not compromise the Club's independence and objectives as outlined in this constitution.

ARTICLE II: OBJECTIVES AND PURPOSE

- (i) To promote and develop the sport of [Sport Name] within the local community.
- (ii) To provide opportunities for individuals of all ages and skill levels to participate in and enjoy the sport.
- (iii) To foster sportsmanship, teamwork, and fair play among members and participants.
- (iv) To organize and participate in competitions, events, and activities related to [Sport Name].

ARTICLE III: MEMBERSHIP

- (i) Membership in the Club shall be open to individuals who share an interest in [Sport / Game Name] and who comply with the Club's membership requirements.
- (ii) The Club may establish different categories of membership, such as full members, associate members, honorary members, and junior members, each with its own rights and privileges.
- (iii) Members shall have the following rights:
 - a. *The right to participate in Club activities and events.*
 - b. *The right to vote on matters requiring the approval of the general membership.*
 - c. *The right to be considered for leadership positions within the Club.*
 - d. *The right to access Club resources and facilities, subject to Club policies and fees.*

ARTICLE IV: GOVERNANCE AND MANAGEMENT

- (i) The Club shall be governed by an Executive Committee, composed of elected members including a President, Vice President, Secretary, Treasurer, and other positions as deemed necessary.

- (ii) The Executive Committee shall be responsible for the overall management of the Club, including organizing events, managing finances, and representing the Club in external matters.
- (iii) Elections for Executive Committee positions shall be held **[specify frequency]** and shall be open to all eligible members. Elected office-bearers shall serve for a term of **[specify term (not exceeding 03 years tenure)]**.

ARTICLE VI: FINANCES

- (i) The Club's finances shall be managed by the Treasurer, subject to the oversight of the Executive Committee. The Club's finances shall be kept in a bank account opened in the name of Club and it shall be jointly operated by the signatories as authorized by the general meeting. All funds shall be used exclusively for the Club's objectives.
- (ii) An annual financial audit shall be conducted by an independent auditor or committee to ensure transparency and accountability.

ARTICLE VII: AMENDMENTS

This constitution may be amended by a two-thirds majority vote of the members present at a general meeting, provided that notice of the proposed amendments is given to members in advance.

ARTICLE VIII: DISSOLUTION

The Club may be dissolved by a two-thirds majority vote of the total members. In the event of the dissolution of the Club, any remaining assets or funds shall be distributed to a charitable organization or cause aligned with the Club's objectives, as determined by a majority vote of the members.

ARTICLE IX: BYLAWS

The Club may establish bylaws and policies to further govern its activities, provided that they do not conflict with this constitution.

ARTICLE X: ADOPTION AND RATIFICATION
