Sealed Tenders are invited from Firms / Companies / Sole Proprietors for auction of Running "Sports Mart" at Nishtar Park Sports Complex Lahore. Tender (Bidding) Documents can be obtained from the office of Assistant Director (Admn), Sports Board Punjab, National Hockey Stadium Lahore during office hours from the date of publication of this Notice till 27th March, 2023 at 02:00 pm, on payment of Rs. 2,000/- (rupees two thousand only Non-Refundable) on account of printing and provision of Tender (Bidding) Documents, in shape of Cash / Bank Draft in favor of Sports Board Punjab, Lahore.

The Tender (Bidding) Documents duly filled in must reach in the office of Assistant Director (Admn), Sports Board Punjab, National Hockey Stadium Lahore by 28th March, 2023 at 11:45 am at the latest. Tenders / Bids (Technical Proposals) will be opened on the same date i.e. 28th March, 2023 at 12:15 pm in Conference Room No. 1, National Hockey Stadium, Lahore, in the presence of the bidders who desire to attend. The detail description, terms & conditions and area / space for running "Sports Mart" are given in the Tender (Bidding) Documents.

- 1. The procedure adopted will be "Single Stage Two Envelops" as prescribed under the Punjab Procurement Rules, 2014.
- 2. The Applicant shall provide all information / documents as required in the Tender (Bidding) Documents.
- 3. The applicant must have minimum eight (08) years past experience in relevant field of business i.e. Sportswear / Sports Shoes / Sport Equipment. In case of Joint Venture, each partner must have minimum 08 years past experience in the relevant field.
- 4. The Applicant must have at least 25 retail outlets / stores network of Sportswear / Sports Shoes / Sport Equipment in major cities of Pakistan.
- 5. The Applicant must be registered / affiliated with SECP, Registrar of Firms or Chamber of Commerce & Industry of Divisional Level City of Punjab.
- 6. The Applicant must have sound financial position having at least Rs. 50 Million annual turnovers.
- 7. The Applicant shall fulfill all mandatory conditions as required in the Tender (Bidding) Documents and must achieve the qualifying marks as per laid down criteria to establish his responsiveness.
- 8. The Applicant is required to submit Technical & Financial Proposals (on the prescribed format duly filled) in separate sealed envelopes. The Financial Proposals of only responsive bidders after technical evaluation shall be considered / opened.
- 9. The Financial Proposal / Bid should accompany Bid Security (refundable) of Rs. 200,000 in the shape of CDR / Pay Order / Bank Draft / Bank Guarantee in favor of Sports Board Punjab.
- 10. The successful bidder shall be required to deposit Security (refundable) of Rs. 1,000,000 in the shape of CDR / Pay Order / Bank Draft / Bank Guarantee in favor of Sports Board Punjab, within 30 days after the receipt of Letter of Award (Work Order).
- 11. The Applicant shall provide his National Income Tax Number (Active), General Sales Tax Registration, undertaking on judicial paper that the Firm / Company / Sole Proprietor has not been blacklisted or past record of terminated / incomplete works or assignments of any Government, Semi-Government, autonomous Body or Organization.

No Tender (Bidding Document) will be entertained after due date. The Procuring Agency reserves the right to reject all bids at any time prior to the acceptance of a bid.
