GENERAL TERMS & CONDITIONS

- *i.* Participants must complete the registration process by submitting the required forms and payment before the specified deadline.
- *ii.* Enrollment is on a first-come, first-served basis, and availability may be limited.
- *iii.* SBP reserves the right to accept or reject any registration at its discretion.
- *iv.* The camp is open to children within the specified age range i.e., U-8 & U-14.
- v. Only one parent/guardian/attendant will be allowed per participant. No guests will be allowed.
- vi. Participants must be in good health and free from any contagious diseases or medical conditions that may pose a risk to themselves or others.
- vii. It is the responsibility of parents/guardians to inform the camp staff of any relevant medical conditions, allergies, or medications that may affect their child's participation.
- viii. The camp staff has the right to restrict participation or take appropriate measures if a participant's health or safety is at risk.
- *ix.* Participants are expected to conduct themselves in a respectful manner, both on and off the field, adhering to the camp's code of conduct.
- *x.* Any behavior deemed inappropriate, including but not limited to bullying, harassment, violence, or disrespect, may result in disciplinary action, including dismissal from the camp.
- xi. Participants and their parents/guardians assume all risks associated with the sports activities, including but not limited to injuries, accidents, and property damage.
- xii. The camp, its organizers, staff, volunteers, and associated entities shall not be held liable for any claims, damages, injuries, or losses arising from participation in the camp, except in cases of willful misconduct or gross negligence.
- xiii. Participants are expected to attend the camp regularly and be punctual for all activities.
